All amendments are indicated in **red**.

Comments/Clarifications	Answer/Response
Clarification on the requirement in the Technical Specifications regarding the approval of the color of the swatches for the carpet tiles.	Ocular inspection of PCOO Office Space prior to bid submission shall be included in the Technical Specifications (<i>please see below</i>) so that the prospective bidders may examine the color of the existing carpet tiles for proper reference. Said bidders shall also bring swatches for comparison. A pertinent certification shall be issued by the End-User Unit representative to the prospective bidder that conducted the required ocular inspection.
